Explanation of applicable data

For the purpose of this policy, personal data refers to information that relates to an identifiable, living individual, including information such as an online identifier, for example an IP address. The General Data Protection Regulation (GDPR) applies to both automated personal data and to manual filing systems, where personal data is accessible according to specific criteria, as well as to chronologically ordered data and pseudonymised data. Data referred to in the GDPR as 'special categories of personal data' (previously termed 'Sensitive Personal Data') specifically includes the processing of genetic data, biometric data and data concerning health matters. "Personal information" is therefore any information that can be used to identify you or that we can link to you and which we at AC Hulme & Sons have in our possession or control.

How do we collect information from you?

We obtain information about you when you use our website, for example, when you contact us about employment, products or services.

How is your information used?

We may use your information to:

- process orders that you have submitted;
- to carry out our obligations arising from any contracts entered into by you and us;
- seek your views or comments on the services we provide;
- notify you of changes to our services;

Privacy Policy for AC Hulme & Sons' Website

We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to fulfil our statutory obligations.

We will hold your personal information on our systems for as long as is necessary for the relevant activity, or as long as is set out in any relevant contract you hold with us.

Who has access to your information?

We will not sell or rent your information to third parties.

We will not share your information with third parties for marketing purposes.

Your choices

You have a choice about whether or not you wish to receive information from us.

If you do not want to receive direct marketing communications from us about our services, then you can select your choices by not completing the relevant boxes situated on the form on which we collect your information. You must complete the relevant boxes with an asterisk in order that we can contact you.

As a result, while we strive to protect your personal information, we cannot guarantee the security of any information you transmit to us, and you do so at your own risk.

Once we receive your information, we make our best effort to ensure its security on our systems. Where we have given (or where you have chosen) a password which enables you to access certain parts of our websites (if developed by us), you are responsible for keeping this password confidential.

If applicable, we ask you not to share your password with anyone.

Links to other websites

Our website may contain links to other websites run by other organisations.

We cannot be responsible for the privacy policies and practices of other websites even if you access them using links from our website.

Transferring your information outside of Europe

As part of the services offered to you through this website, the information which you provide to us may be transferred to countries outside the European Union ("EU"). By way of example, this may happen if any of our servers are from time to time located in a country outside of the EU. These countries may not have similar data protection laws to the UK.

By submitting your personal data, you are agreeing to this transfer, storing or processing. AC Hulme & Sons uses CCTV for the purposes of health & safety of its employees and visitors and also the detection and prevention of crime and understands that recording images of identifiable individuals constitutes as processing personal information. Where CCTV is used it will be done in line with data protection principles. AC Hulme & Sons will notify all colleagues and visitors of the purpose for collecting CCTV images via notice boards, letters and email, along with any retention rules on such data.

Cookie Policy

Use of 'cookies'

Like many other websites, the AC Hulme & Sons website uses cookies. 'Cookies' are small pieces of information sent by an organisation to your computer and stored on your hard drive to allow that website to recognise you when you visit. They collect statistical data about your browsing actions and patterns and do not identify you as an individual.

For example, we use cookies to store your device and browser preference. This helps us to improve our website and deliver a better more personalised service.

What types of cookies are there?

Broadly, there are 4 types of cookie:

Strictly necessary cookies: These are cookies that are essential to make a website work and enable features that users have specifically asked for. These types of cookies are commonly used with shopping baskets or e-billing. Without use of cookies, these features of the website could not operate.

Performance cookies: These cookies collect anonymous information about users for the purpose of assessing the performance of a website. Common uses include well-known web analytics tools such as 'Google Analytics'.

Functionality cookies: These are cookies that automatically remember choices that users have previously made in order to improve their experience next time they visit a website. For example, where users select their preferred settings and layout.

Targeting or Advertising cookies: These cookies are similar to performance cookies, in that they collect information about users' behaviour. However, this information is used at individual user level to advertise products and services to users on the basis of the behavioural information collected.

What cookies does the AC Hulme & Sons website use?

We use both Strictly Necessary and Performance cookies.
